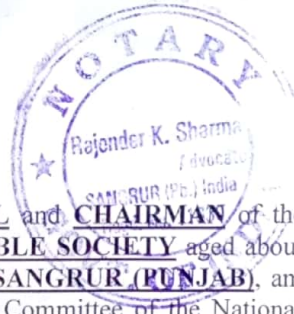




AFFIDAVIT
